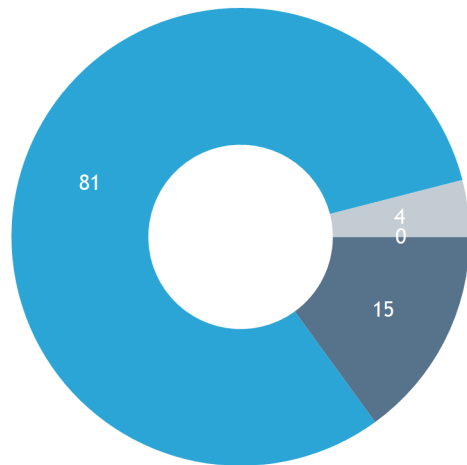

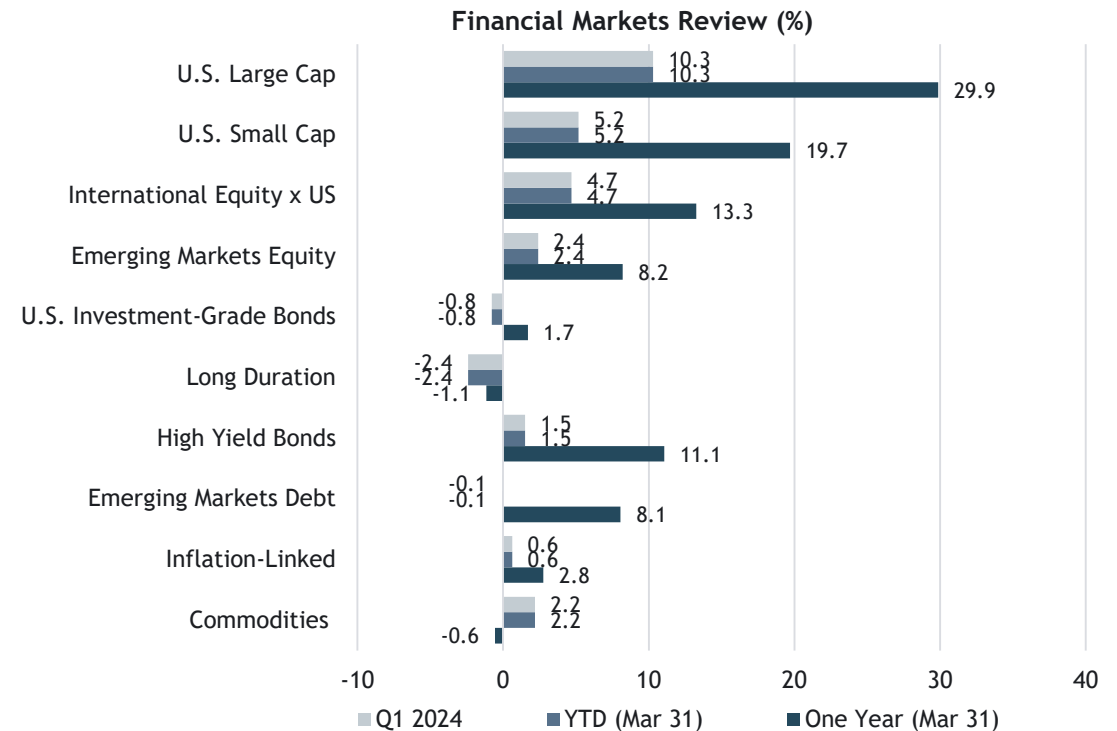

Market performance overview

- Major global equity market indexes moved higher in March 2024, driven in part by investors' continued optimism regarding interest-rate cuts from central banks later this year. This comes in spite of several hotter-than-expected inflation reports released over the month.
- Developed markets outperformed their emerging-markets counterparts over the period.
 - The eurozone led the major developed markets in March, driven by strong performance from several countries, including Spain, Austria, Italy, and Ireland. The Pacific region was the primary developed-market laggard, as Hong Kong and New Zealand recorded negative returns for the month. Latin America was the top-performing region within emerging markets for the month, led by strength in Peru and Colombia. Conversely, the Middle East was the most notable underperformer due to relative weakness in Jordan, Egypt, and Morocco.
- U.S. equities (as represented by the S&P 500 Index) rose 3.22% during the month.
- Value stocks outperformed growth stocks. Large-capitalization value stocks outperformed small-capitalization value stocks. Small-capitalization growth stocks outperformed large-capitalization growth stocks.
- U.S. Treasury rates were relatively flat for the month, neither rising nor falling more than 8 basis points at any given maturity. Bond prices fall as yields rise.
- The Fed's so-called dot plot of economic projections indicated a median federal-funds rate of 4.6% at the end of 2024, unchanged from its previous estimate issued in December, signaling that the central bank still may reduce the federal-funds rate by roughly 75 basis points (0.75%)—most likely in three increments of 25 basis points—by the end of the year. The dot plot also projected that core personal-consumption-expenditures (PCE) inflation could tick up from its most recent annual increase of 2.4% in January to 2.6% by the end of 2024. The PCE price index is the Fed's preferred gauge of inflation, as it tracks the change in prices paid by or on behalf of consumers for a more comprehensive set of goods and services than that of the consumer-price index (CPI).
