History

First Community Foundation Partnership's (FCFP) roots go back over a century to the birth of the community foundation movement. In 1916 a group of bankers founded the Williamsport Foundation - the first community foundation in Pennsylvania - with just \$33 in donations.

In 2004, First Community Foundation Partnership of Pennsylvania was created as a regional foundation. Soon after, the Foundation expanded its regional footprint into Montour and Union Counties. Today FCFP serves north central Pennsylvania while focusing efforts in Lycoming, Montour, Northumberland, Snyder and Union Counties. We also reach into Bradford, Clinton, Columbia, Potter, Sullivan and Tioga Counties through donors and their geographic area funds and scholarships.

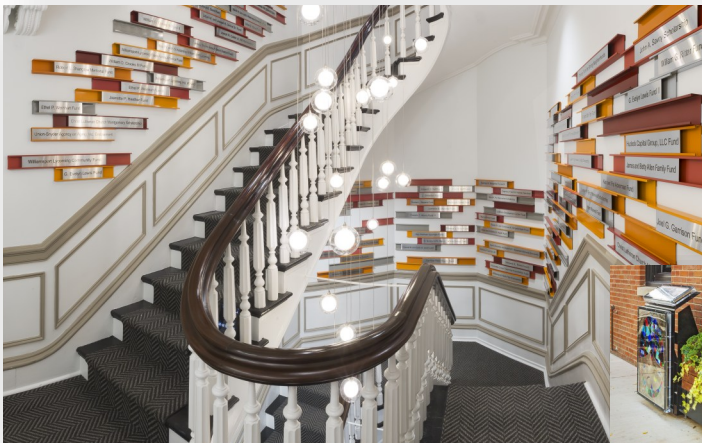
